4. Votes:

a. Master of Arts in Educational Studies (Heba, Joe, Jennifer, John, Brenda, Alyssa)

Linda Mayger presenting on the MAES program. It creates a Master's degree by combining programs that already exist. Three School of Ed departments and iSTEM have worked together to create the degree. The different pieces that get combined into the Master's are integrated together at the end through an interdisciplinary research project. The research project culminates in a final paper, and the student is paired with a faculty mentor that guides them in the development of the project over the course of the semester. When students arrive at the course, they must already have a formalized idea, and there are informal procedures in place to help them develop that along the way. There was a question about whether a statement about IRB exemption should be added to the research course description. The program will be sent to the state for approvals as a piece of the process. The certificate programs being included have already been vetted and approved.

Motion to approve the proposal, with some additional language in an addendum added to define what a stackable certificate is and to clarify what the IRB implications of the research course are

b. Master of Public Policy (Sharon, Brenda, Alyssa)

Daniel Bowen presenting on the MPP program. Professional Master's degree focused on training students for careers in public affairs, public service, management, public policy, largely in the public sector but also some areas of the private sector. Some students may want to get the Public Policy certificate as a way into MPP, and some other students on campus may want to add the PP certificate to their disciplinary training. Question about how non-matriculated students would access, there is no non-matriculated certificate program at the moment. The current proposal currently has 2 double-counted grad/undergrad courses allowed based on TCNJ policy, but this means that students would need to potentially take a winter or summer course to finish the PP certificate. As a goal they are hoping for 8-12 students starting out in the 4+1 program. Adding working class adults already in local/state government could grow this further to 25-30 students. General discussion about how the approval of this program and other Master's/certificates programs will also require support at the administrative level. What is the justification for 2 course releases per year for a class of 12 students? The coordinator will take on advising, setting up internship site placements, scheduling and coordinating the courses for the MPP, and a lot of in-house professional development, training, networking, etc. The general discussion was that this is a great program, but there were significant concerns about the actual revenue generating potential of the program going forward, and of Master's /4+1 programs being the panacea answer to TCNJ budget shortfalls. Approved.

c. Graduate Certificate in Health and Risk Communication (Avani and Tracy)

Tracy Kress and Avani Rana briefly discussed the program and said it checks off all of the appropriate boxes for a certificate program based on their review. **Approved.** Proposal sent to the Graduate Studies Council.

d. Delivery Mode

Clarification requested about what faculty training is required for faculty to teach in certain modalities. Discussion about approval of an interim policy that includes the definitions so that they can be ready for the fall. But additional work was suggested to be done to edit the policy that OID cannot require training of faculty to teach courses, and that this is something that should be determined within the academic unit (e.g., Dean and department). There are also additional feedback/testimony steps of the process that need to occur going forward.

Motion that we approve definitions on an interim basis while there is further review and feedback obtained for the full policy: **Approved**
