  - i. Student Complaints Policy 5-year review
    - 1. Reviewed testimony
      - a. Should there be a form to formally file a complaint?
        - i. Helpful to standardize and distinguish it from an informal complaint, but would change the process because form would go to centralized office (e.g.,

- Academic Affairs) which might discourage students from bringing complaints
- ii. Add language that records should be retained when appeals occur (e.g., to chairs, deans), and acknowledgment of receipt of complaint should be required
- b. Add statement referencing ADA policy for concerns about accommodations not being met
- c. Clarify the distinction between this and student conduct policy
- d. Remove language specifying reporting window for students and focus on instructor timeline for response/resolution
- e. Should classroom-based complaints during winter/summer terms automatically be expedited?
- f. Add this policy to the syllabus resources
- g. Rename to something like "Academic and Academic-Related Complaints Policy" to clarify that it is not for complaints about housing, dining, etc.
