## II. Items that require action

#### A. Minutes (2/14/23)

Teresa Nakra motioned to approve amended minutes, Gary seconded, all in favor Minutes approved.

#### B. Emeritus Status - Faculty policy review

- 1. Discussion about the inclusion of Adjunct Emeritus. May not be feasible in the current scenario.
- 2. Discussion about Library resources. We may need to check library resources. Keep library privileges generic.
- 3. Listing Emeritus faculty names on the departments' websites is the department's discretion.
- 4. Recommendation of changes under A. Eligibility:
  - a) A strong case for senior and master lecturer /senior clinical specialist (Not tenured) can be added to the eligibility criteria after removing the bullet "Faculty must be tenured" from the requirements of Emeritus status.
  - b) May remove Librarian II and add Assistant Director.
  - c) Discussion about the bullet "Full time"? Only part-time Librarians may be affected by this. Most likely, no faculty will fall into this category.
  - d) "The department and the Dean recommend faculty member for Emeritus status" can be added?
  - e) The bullet may be added: "Retired in good standing with no pending disciplinary actions and felony conviction within <u>some</u> time frame."

- f) "Assistant professors (the hire date must be before 1990)" relates to the date when tenure was separate from promotion
- 5. Recommendations and Discussion under A. Rights and Privileges:
  - a) They can be PI and Co-PI with the cooperation and approval of the respective dean.
  - b) We may not need the bullet: "They may be eligible to teach in an adjunct capacity."
- 6. Discussion about Emeritus appointment and Process
  - a) This position is on contract basis (3-year or 4-year contract) College has the right not to extend the contract without explanation.
  - b) They need peer reviews and department PRC to make recommendations.

### 7. Next Steps

- a) A draft with Preliminary recommendations will be sent to the stakeholders. Steering committee, HR, Academic Affairs, Department Chairs? Faculty should be made aware or not?
- b) Our Preliminary recommendations are due by March 15<sup>th</sup>.
- c) Can we meet and vote asynchronously? The motion to vote asynchronously is approved.
- d) After CFA approval, send it to the dean for comments and the steering committee. CFA may approve it in the coming week.
- C. New Charge from Steering: Review Section 5 of the 2026 Community Engagement Reclassification Guide.
  - 1. Careful about any change in Reappointment and Promotion Document because it has extensive review process.
  - 2. A subcommittee has been formed to work on edits in the promotion document. Members include Bethany Sewell, Tim Clydesdale, Brenda Ghitulescu, Teresa Nakra
  - 3. Section 5 of the Document is about Faculty and Staff.
  - 4. Do we value community engagement and our values reflects in the RPD? Match engagement requirements with RPD.
  - 5. Timeline of change to this charge. It may be due in early April.
  - 6. Subcommittee can present their thoughts by March 27<sup>th</sup>.
- D. Two New Disciplinary Standards (African American Studies and History Departments)
  - 1. We may give feedback after spring break.
